The undersigned hereby grants his/her consent to the Holbrook Chamber of Commerce and any producer, in perpetuity, to display the likeness of the undersigned (or his/her minor child) in any related promotional use.

RISKS, HAZARDS AND DANGERS ASSOCIATED WITH PARADE PARTICIPATION
Parades involve inherent risks, hazards and conditions that may be dangerous to life, limb and property and that can arise in an incalculable variety of unforeseeable or foreseeable ways which may include (as examples, but not necessarily as a complete list) the following: The presence and use of horses and other animals, motor vehicles, machinery, firearms, floats, fireworks, acrobats, projectiles, aerial demonstrations, baton twirling, wind, rain, hail and other force of the elements, and other threats to life and limb, such as the possibility of slipping and falling and complications associated with weather conditions and physical exertion (such as heat stroke, cold weather, fainting, collapse, exhaustion or other more serious complications).
